IMPORTANT DATES

21 FEB 2018 - Election opens for SOLBE1 shareholders

You can now elect to keep your shares and participate in Sasol Khanyisa

22 MAR 2018 - Election closes

This is the final date for your election decision to be sent to Computershare

5 APR 2018 - SOLBE1 Re-designation

If you did not elect to participate in Sasol Khanyisa your SOLBE1 shares will automatically become Sasol shares (SOL)



You will not be able to trade your shares from the day your election is received until 5 April 2018 when trading will resume

YOU HAVE A CHOICE TO RETAIN OR RE-DESIGNATE

WHAT HAPPENS IF I RETAIN MY SOLBE1 SHAREHOLDING?

You will be awarded **1 SOLBE1 Bonus Share** for every **4 SOLBE1 shares** that you hold, at no cost to you

Your **100 SOLBE1 shares** will become **125 SOLBE1 shares** in June 2018



You will be invited to participate in Sasol Khanyisa from April 2018. SOLBE1 shares bought after 6 February 2018 are not eligible for the 1 in 4 bonus shares

WHAT HAPPENS IF I RE-DESIGNATE MY SOLBE1 SHAREHOLDING?

If you decide **NOT** to retain your shares / or if you **FAIL TO RESPOND**

Your **100 SOLBE1 shares** will convert to **100 SOL shares** on 5 April 2018



You will not receive any bonus shares, nor will you be eligible to participate in Sasol Khanyisa. Your SOLBE1 shares will automatically become Sasol shares (SOL)
